

**96.3KKLZ's Vacation to the Disneyland® Resort
OFFICIAL CONTEST RULES**

These rules apply to the 96.3 KKLZ & Disneyland® Resort Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a KKLZ-FM 96.3 KKLZ (“Station”). **In addition, the General Contest Rules posted at www.963KKLZ.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, March 2, 2026 and end on Friday, March 13, 2026.
- b. To enter on-air, listen to the Station each weekday beginning on Monday, March 2, 2026 and ending on Friday, March 13, 2026 between the hours of 7:00AM Pacific Time (“PT”) and 5:00pm PT for the announcement of a “Magical Wand/Twinkling” sound, which will serve as the cue to call. Upon hearing the cue to call, caller number ninety-six (96) to the Station contest line at 1-702-739-9636 will win a Qualifying Prize and be qualified for a chance to win the Grand Prize (each deemed a “Qualifier”), upon confirmation of eligibility. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once. **Up to nineteen (19) on-air Qualifiers will be selected.**
- c. For an additional chance to qualify, entrant may enter online. To enter online, visit www.963kklz.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Monday, March 2, 2026 at 7:00am PT and ending on Friday, March 13, 2026 at 11:59pm PT (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator. **Up to one (1) online Qualifier will be selected at approximately 8:00am PT on Monday, March 16, 2026 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Qualifier will be notified by phone and/or email promptly**

following the random drawing.

- d. There will be up to a total of nineteen (19) Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest. **An entrant may be deemed a Qualifier only once in the Contest, regardless of method selected.**

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Clark County, NV, and Mohave County, AZ, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to nineteen (19) Qualifying Prizes will be awarded. Each Qualifying Prize consists of a family four (4)-pack of 2-Day/1-Park Per Day Tickets to Disneyland (valid for winner and three (3) guests). Approximate Retail Value (“ARV”) of each Qualifying Prize is \$1,320.00.

WINNER IS SOLELY RESPONSIBLE FOR TRANSPORTATION TO/FROM ANAHEIM, CA. STATION IS NOT RESPONSIBLE FOR ANY TRAVEL COSTS INCURRED AS PART OF THE WINNER’S AND GUESTS’ TRANSPORTATION TO/FROM ANAHEIM, CA. Tickets expiration date is 12/15/2025. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. **Qualifying Prize winner will receive from the Station an IRS Form 1099 (or similar) in the amount of the Qualifying Prize for the 2026 tax year.**

- a. Up to one (1) Grand Prize will be awarded. The Grand Prize will consist of a two (2) night stay (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) at one of the Hotels of the Disneyland Resort (“Premises”) with

parking, and four (4) 3-Day, 1-Park Day Tickets. ARV of the Grand Prize is \$3,212.00.
Note: Grand Prize winner will only receive the Grand Prize and not both the Qualifying Prize and Grand Prize.

- Lodging for the Vacation Package must be completed prior to **March 15, 2027**.
- Vacation Package fulfillment and travel are subject to certain restrictions certain hotel/room availability at the Premises. The Vacation Package must be booked through a travel agent as designated by Disney at least forty-five (45) days prior to arrival. Block-out dates apply. No extensions will be granted (unless stated otherwise). Certain lodging restrictions apply. Theme park tickets are subject to the terms and conditions set forth herein and included on the theme park tickets.
- Both a theme park ticket and separate theme park reservation for the same park on the same date are required for park entry for the winner and each Guest. Theme park reservations and tickets will be required for each day of the visit and must be obtained before visiting. Park reservations are limited and subject to availability. Park reservations do not guarantee park admission or access to any experience, attraction, or offering. - Winners must be at least the age of majority pursuant to his/her applicable state of residence to enter and win. A Guest under the age of majority must be accompanied by his/her parent/legal guardian who must be at least the age of majority and both will be deemed Guests of the winner (unless the winner is the Guest's parent or legal guardian). Once selected by winner, Guests cannot be changed without the express consent of Disney, which may be withheld for any reason.
- Vacation Package and its components (including, without limitation, theme park tickets) may not be used in conjunction with any other promotion or offer, separated, sold, exchanged or redeemed for cash, traded, transferred, substituted, assigned, or rescheduled to dates other than as set forth above, except in Disney's sole and absolute discretion.
- The Vacation Package will not include the following: transportation to/from the Premises; insurance (health, travel, medical); parking fees (unless stated otherwise); room service, laundry service, spa treatments; food or beverages; merchandise, souvenirs; incidental expenses; local or long distance telephone calls; tips, gratuities, service charges; any taxes; or any other charges not explicitly included herein.
- All elements of the Vacation Package (including, without limitation, the theme park tickets) must be used by the Group on the same dates during the redemption of the Vacation Package. Any portion of the Vacation Package not accepted or used by winner will be forfeited.

- Certain theme parks, hotels, restaurants, attractions, experiences, services and other offerings may be modified, limited in availability and capacity, or be closed.
- A winner may not charge any Guest for participating in the prize. Prizes are awarded "as is" with no warranty or guarantee, expressed or implied, being provided by Station or Disney.
- The winner and his/her Guests are responsible for having valid travel documents including government-issued identification and/or passports, as applicable.
- The winner will not receive compensation for any element(s) of the Vacation Package (including, without limitation, theme park tickets) that any participant(s) is unable to use for any reason, and such unused portion(s) of the Vacation Package will be forfeited.
- If the winner chooses to bring less than the allotted number of Guests, the Vacation Package will be awarded in increments suitable for the actual number of participants with no substitute prize or compensation provided to the winner.
- The winner and his/her Guests will be required to execute a liability/publicity/COVID-19 release and waiver form prior to booking of any travel. Failure to return the executed release form within the specified time period will result in forfeiture of the Vacation Package. Winner acknowledges that he/she is solely responsible for any actions, claims or liabilities of the Group, related to any use or misuse of the prize or any prize-related activity or travel.
- Any damaged, lost or stolen theme park tickets, gift cards, or travel vouchers will not be replaced. Gift cards are not redeemable or exchangeable for cash (except as required by law) and are subject to all terms and conditions of use as established by issuer.
- There may be specific state or government health agency instructions, guidelines and requirements for all visitors to the Premises. The winner and their Guests are solely responsible, at their own cost, for staying updated on and complying with any of the latest restrictions and requirements that may be in place for travel to and visiting the Premises leading up to the planned stay. Such restrictions and requirements are subject to change.
- The actual value of the Vacation Package may vary depending on fluctuations of hotel rates. Any difference between the approximate retail value and the actual cost of the/each Vacation Package will not be awarded.

Certain restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, airfare, taxes, meals, tips and transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. No refund or compensation will be made in the event of the cancellation or delay of any Prize-related Event. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. **Grand Prize winner will receive from the Station an IRS Form 1099 (or similar) in the amount of the Grand Prize for the 2026 tax year.**

- b. Prizes or prize certificates must be claimed as described by the Station at the time of winning. Prize or prize certificate must be claimed within ten (10) business days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to twenty (20) Qualifiers will be selected on-air and online as described above.
- b. Up to one (1) Grand Prize winner will be selected at approximately 9:00AM PT on

Monday, March 16, 2026 in a Station-conducted random drawing from all Qualifiers. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.

- c. Odds of winning a Qualifying Prize on-air depend upon the number and order of calls received. Odds of winning a Qualifying Prize via the online-only method of entry depend on the number of eligible online entries received during the Online Entry Period. Odds of a Qualifying Prize winner winning the Grand Prize are up to 1 in 20.
- d. Entrants must listen to the Station to win a Qualifying Prize on-air but do not need to be present to enter or win. Entrants need not listen to the Station or be present to win a Qualifying Prize online. Qualifiers do not need to listen to the Station or be present to win the Grand Prize.
- e. Qualifying Prize winners must confirm acceptance of the prize within ten (10) days of winning, or risk disqualification and an alternate Qualifying Prize winner will not be selected. Grand Prize winner must confirm acceptance of prize within five (5) days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.
- f. Decisions of Station management with respect to the Contest are final.
