

**96.3 KKLZ Beat the Heat**  
**Powered by Sun City Heating & Cooling**  
**OFFICIAL CONTEST RULES**

These rules apply to the 96.3 KKLZ Beat the Heat powered by Sun City Heating & Cooling Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a KKLZ-FM 96.3 KKLZ (“Station”). **In addition, the General Contest Rules posted at [963KKLZ.com](http://963KKLZ.com) apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

**1. HOW TO ENTER**

- a. The Contest will begin on Monday, June 3, 2024 and end on Friday, June 14, 2024.
- b. To enter on-air, listen to the Station each weekday beginning on June 03, 2024 and ending on June 14, 2024 between the hours of 6:00am Pacific Time (“PT”) and 5:00pm PT, for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced on-air at the time of the cue to call) to the Station contest line at 1-702-739-9636 will win a Qualifying Prize and be qualified for a chance to win the Grand Prize (each deemed a “Qualifier”), upon confirmation of eligibility. The caller may be required to correctly answer a trivia question(s) in order to be deemed a Qualifier at the sole discretion of the Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once. **Up to three (3) Qualifiers will be selected each weekday.**
- c. For an additional chance to win, entrant may online; to enter online [www.963kklz.com](http://www.963kklz.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Monday, June 3, 2024 at 6:00am PT and ending on Friday June 14, 2023 at 11:59pm PT (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- d. There will be up to a total of thirty-one (31) Qualifying Prize winners (thirty (30) on-air and one (1) online) and one (1) Grand Prize winner selected in the Contest. **An entrant may only be deemed a Qualifier once regardless of method selected.**

## **2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Clark County, Nevada, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.
- b. In order to claim the Grand Prize, the winner must own the home where the Grand Prize will be installed and may be required to show proof upon request.

## **3. PRIZES**

- a. Up to thirty-one (31) Qualifying Prizes will be awarded. Each Qualifying Prize consists four (4) tickets to Cowabunga Vegas. The Approximate Retail Value (“ARV”) of each Qualifying Prize is \$187.96.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

- b. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of one (1) American Standard Unit from Sun City Heating and Cooling and includes delivery and installation, as described below. ARV of the Grand Prize is \$24,000.

Prize Provider agrees to include the following as part of each Prize:

- a. Removal of existing equipment
- b. New breaker
- c. Reconnect to existing duct work, making an airtight plenum transition and sealing all new duct connections with mastic
- d. Reconnect to existing flue piping
- e. Reconnect to electrical (Not responsible for the condition of existing electrical lines)
- f. Reconnect to gas piping (Not responsible for the condition of existing gas lines)
- g. Reconnect condensate drain system (Not responsible for the condition of

- existing condensate drain)
- h. New auxiliary drain pan with safety float switch when a complete system (all indoor and outdoor equipment) is installed in attic or basement
  - i. New carbon monoxide detector
  - j. Meet all code requirements including pulling all necessary permits and help to arrange county inspections when possible
  - k. Complete system check, test, and start up including cleaning our work area (see Peace of Mind Guarantees below)
  - l. Sun City Heating and Cooling will perform one (1) quality inspection of the new system approximately six (6) months after installation.
  - m. Manufacturer provides 10-year parts warranty to the original winner only
  - n. Accessories carry a 1-year parts warranty only
  - o. When applicable, the heat exchanger warranty is at least 20 years or if a condensing furnace is installed the heat exchanger warranty is extended to a lifetime warranty
  - p. Sun City Heating and Cooling will provide a 5-year labor warranty with the installation
  - q. If the above system is not sufficient for a winner's home, Prize Provider may choose to install a unit of higher value, in the Prize Provider's discretion at no additional cost or expense to the Station or the winner
  - r. To replace an existing unit with a comparable high efficiency new Trane unit not to exceed \$24,000.00 (since the type of house etc. will affect what is needed for the install)
  - s. One system only
  - t. Winner will receive COMPLETE AC unit replacement within 90 days after announced on-air barring any unseen supply shortages.

**Winner is solely responsible for any cost(s) associated with building or construction permits required by any applicable federal, state or local law or regulation, as well as any tax liabilities resulting from accepting the Grand Prize.**

- c. Prizes or prize certificates must be claimed at the office of the Station located at 2920 S Durango Dr Las Vegas, Nevada 89117, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within ten (10) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

#### **4. SELECTION OF WINNERS**

- a. Up to thirty (30) on-air Qualifiers will be notified and selected as described above.
- b. Up to one (1) online Qualifier will be selected at approximately 6:00am PT on June 17, 2024 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Qualifying Prize winner will be notified by phone and/or email promptly following the random drawing.

- c. Up to one (1) Grand Prize winner will be selected at approximately 8:00AM PT on Monday, June 17, 2024 in a Station-conducted random drawing from all Qualifiers. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.
- d. Odds of being deemed a Qualifier on-air depend in part on the number and order of calls received. Odds of deemed a Qualifier online depend on the number of eligible online entries received during the Online Entry Period. Odds of a Qualifier winning the Grand Prize are up to 1 in 31.
- e. Entrants must listen to the Station but need not be present to be deemed a Qualifier on-air. Entrants via the online method of entry need not listen to the Station or be present to be deemed a Qualifier. Qualifiers need not listen to the Station or be present to win the Grand Prize.
- f. Grand Prize winner must confirm acceptance of prize within ten (10) days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.
